**NOTICE TO PARTIES REQUESTING REPORTS CONTAINING
BANKRUPTCY FILING INFORMATION**

The Clerk's office regularly receives from various persons and business entities requests that reports be generated for them that include certain bankruptcy filing information such as lists of discharged cases that include the debtors' names and addresses. The policy of the Clerk's office is not to generate any requested customized reports because to do so would require the clerk's office to utilize its limited information technology resources to generate reports in a specialized format.

The Bankruptcy Court Administration Division of the Administrative Office of the United States Courts advises that the clerk's office is not required to use its automation capabilities to compile customized data upon request of a person or entity. Such customized reports are not "public records" within the meaning of 11 U.S.C. Section 107(a).

Certain standardized reports of bankruptcy filings are available to the public through the Public Access to Court Electronic Records (PACER) service run by the Administrative Office of the United States Courts. To obtain a standardized report or other bankruptcy filing information through PACER, you must register with PACER and obtain a PACER login and ID. There is a charge of 8 cents a page for reports or other case information generated. You may register with PACER and obtain more information regarding PACER at their web site, www.pacer.uscourts.gov.

With a PACER account, you will be able to access the following standard reports.

The Cases Report will permit you to generate reports by a date range for the following types of dates, one of which is the Discharged Date.



The report generated will include a list of cases (in this example discharged cases) for the date range you specified.

If you need additional information for the cases on the list, you may click on the Case Number hyperlink to obtain additional case information such as the addresses of the debtor or other parties and access to the docket and filings made in the case. Please be advised that you will be charged the 8 cents per page fee for the report and any additional information you seek.

If you have Internet access in your home or at your place of business, you can obtain whatever reports and bankruptcy filing information that is available on PACER directly from your home or office after you have obtained a PACER account. If you do not have access to the Internet, you may visit the clerk's office during our office hours of 9:00 am to 4:00 pm weekdays (except for holidays) and access the same PACER information without having a PACER account. However, any reports or case information printed at the clerk's office will be subject to a fee of ten cents per page.
