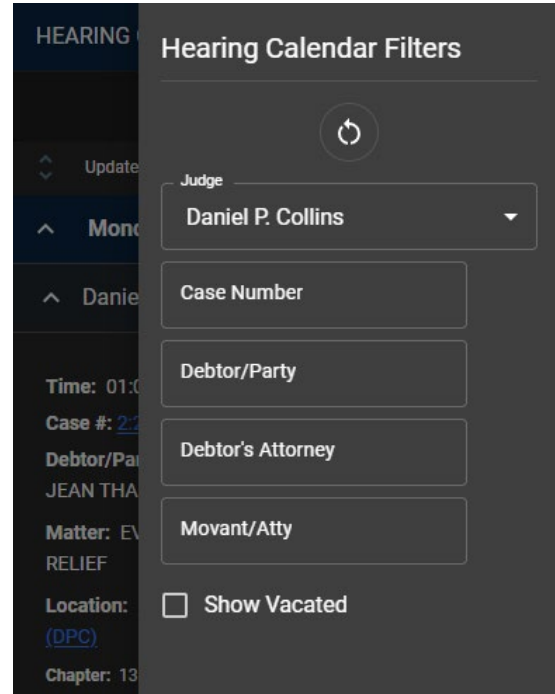
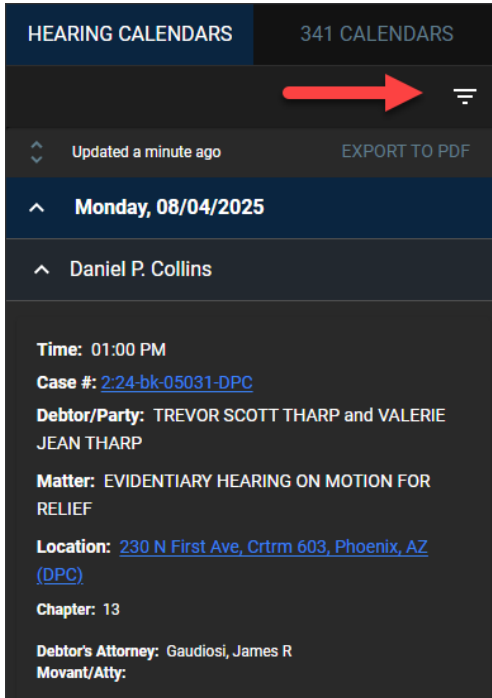

Hearing Calendar Mobile View

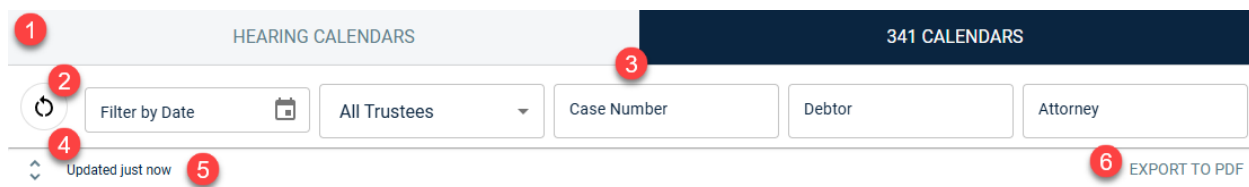
