<b>Rule or Form</b>	<b>Title</b>	<b>Note / Explanation Regarding Amendment</b>
2084-1	Scope and Definition – Chapter 13 Rules	Minor text changes to simplify language concerning the scope of the 2084 series; new section added to include definitions relevant to chapter 13 matters
2084-2	Filing Requirements <i>See related Form</i>	Amended to require self-employed or engaged in business debtors to use new Local Form 2084-2 Business Operating Statement; language simplified
2084-3	Attorney Fees	Incorporates former General Order 106, including specifying minimum required services that must be provided for no-look flat fee compensation; clarifies procedures for flat and hourly fees; adds provision for payment of fees upon dismissal
2084-4	Plan <i>See related Forms</i>	Requires Local Form 2084-4 Plan to be used for all original, amended, or modified plans (may no longer file summary of changed terms); provides additional instructions for completing form plan; authorizes trustee to give notice of intent to lodge dismissal order for failure to properly file plan and then to lodge order for immediate dismissal; requires defaulted residential mortgage payments to be paid through trustee unless otherwise ordered; establishes duties of debtors, trustees, and creditors and implements conduit payments to be implemented through use of Forms 2084-4A & B
2084-5	Tax Returns	Adds authorization for notice of commencement of case to include warning of summary dismissal for failure to file required returns
2084-6	Adequate Protection Payments	Clarifies that LR applies to all personal property; Adds text concerning payment upon pre-confirmation dismissal; Minor text changes
<b>NEW</b> 2084-7	Rescheduled or Continued Meeting of Creditors	New LR establishes notice procedures for a rescheduled or continued Meeting of Creditors (incorporates portion of subpart (f) of former LR 2084-8 (now vacated) concerning continuance of 341 meeting; clarifies that rescheduling or continuance is at trustee’s discretion
2084-8	<del>RESERVED</del> <del>Serving the Plan or Motion for Moratorium</del>	Vacated; text concerning service of Plan incorporated into LR 2084-4 and text concerning continuing meeting of creditors incorporated into LR 2084-8; balance of LR deleted

Rule or Form	Title	Note / Explanation Regarding Amendment
2084-9	Creditor Objection to Plan	Resets objection deadline in the event of a continued 341 Meeting or reinstatement (the later of 14 days of continued 341 or 28 days after service of the plan); establishes separate objection deadlines based upon whether a case is dismissed before or after a 341 Meeting is held
2084-10	Trustee's Recommendation /Objection	Amendments authorize trustee to lodge dismissal order if no plan payments have been made by deadline for trustee's recommendation; authorize trustee to give notice of intent to lodge dismissal order and then to lodge order for immediate dismissal should debtor fail to comply with trustee recommendation/evaluation or request a hearing; incorporates concept from former LR 2086-16 (now vacated) that Court may summarily overrule any objection that fails to identify the issues or other impediments to plan confirmation
2084-11	Hearing on Objection or Confirmation	Language simplified; advises that any party in interest may set a hearing on confirmation
2084-12	Confirmation of Plan without hearing	No substantive change but clarifies that trustee's signature is required on Stipulated Order of Confirmation
2084-13	Order Confirming Plan	Sets forth procedures for obtaining confirmation and when payments shall commence; creates uniform 45 day periods
<i>NEW</i> 2084-14	Confirmation Status Hearing	Establishes that any party in interest may set a confirmation status hearing
2084-15	Trustee's Motion to Dismiss	Clarifies that case will be summarily dismissed if debtor fails to comply with requirements of Local Rules
2084-16	<del>RESERVED Debtor's Objection to Proposed Dismissal Order</del>	Vacated; former LR requiring debtor to identify the issues or impediments to plan confirmation has been incorporated into LR 2084-10(b); balance of LR deleted
2084-17	Vacating Dismissal Order	Language simplified and updated to reflect that dismissal orders are vacated – no substantive changes
2084-18	Plan Payments	Minor edits – no substantive changes
2084-19	<del>RESERVED Priority or Secured Claims</del>	Vacated; former LR concerning electronically filing secured or priority claims deleted (such requirement is now subsumed in amended LR 5005-4)

<a href="#">2084-23</a>	Stay Relief to Secured Creditors	Language simplified; directs trustee to cease making payments on the secured claim of a creditor who has obtained stay relief, unless otherwise ordered by the court or directed by the parties
<a href="#">2084-25</a>	Sale of Property or Incurring New Debt	Amendment clarifies that required information applies in both pre-confirmation ex-parte motions for orders and post-confirmation requests for written authorization from Trustee
<a href="#">2084-26</a>	Debtor Completion of Plan Requirements; Discharge <i>See related Form</i>	Amendment requires debtor to file Local Form 2084-26 before Court will enter discharge
<b>NEW</b> <a href="#">2084-27</a>	Transmission of Documents with Personally Identifiable Information to Trustee	New LR requires Personally Identifiable Information (PII) to be redacted and authorizes trustees to require documents with PII to be submitted through specific method or portal
<b>NEW</b> <a href="#">2084-28</a>	Electronic Service On Chapter 13 Trustees	New LR provides that electronic service of process on trustees must be accomplished in accordance with instructions on Court's website
<b>NEW</b> FORM	Chapter 13 Monthly Business Operating Statement	<a href="#">Form 2084-2</a> – Chapter 13 Monthly Business Operating Statements
<b>UPDATED &amp; RENUMBERED</b> FORM	Chapter 13 Plan	<a href="#">Form 2084-4</a> – Chapter 13 Plan – Amended to conform to National Plan requirements and renumbered from 13-2
<b>NEW</b> FORM	2084-4A Mortgage Creditor Checklist	<a href="#">Form 2084-4A</a> – Conduit Mortgage Payment form for use by Trustee
<b>NEW</b> FORM	2084-4B Authorization to Release Information to the Trustee Regarding Secured Claims Being Paid by the Trustee	<a href="#">Form 2084-4B</a> – Conduit Mortgage Payment form for debtor to allow mortgage creditor to release information to Trustee
<b>UPDATED</b> FORM	2084-26 Certificate of Eligibility for Chapter 13 Discharge After Completion of Plan Payments	<a href="#">Form 2084-26</a> – form updated
