The Debtors filed an adversary proceeding naming the Arizona Department of Revenue as defendant. However, in the body of the complaint, the Debtors/Plaintiffs seek relief not against the Arizona Department of Revenue but against the Internal Revenue Service, a federal government agency. Therefore, the complaint makes no allegations against the defendant that is named while at the same time seeking relief against an unnamed nondefendant.

These infirmities are sufficient to deny the application for a default judgment. More importantly, however, the complaint does not state a complaint upon which relief may be granted. The complaint does not identify the taxes that are in dispute and whether they qualify for exception from discharge under section 523(a)(1). Rather, the complaint seeks relief under section 523(c) which has no substantive provision concerning the dischargeability of taxes. The apparent basis of the claim is that the Debtors seek a discharge of certain taxes because it is a hardship to pay them. There is no provision in the Bankruptcy Code allowing a "hardship discharge" for taxes.

For the foregoing reasons, the Debtors' application for entry of default judgment will

1	be denied and the Court, on its own motion, will dismiss the Plaintiffs' complaint.
