Plaintiff Kersin Montierth claims to be a creditor of the Debtor and that she did not receive notice of the pendency of this bankruptcy case, or the time to object to discharge, prior to entry of the Debtor's discharge on March 31, 2003. Consequently she has filed a complaint seeking an opportunity to object to discharge under Bankruptcy Code §§ 523 and/or 727.

Plaintiff bases her status as a creditor on two judgments rendered by the California Superior Court for Contra Costa County on November 26, 2002 and April 16, 2003. Both of those judgments were entered after this case had been filed on September 23, 2002, and are therefore void as in violation of the automatic stay. Nevertheless, Plaintiff may be a creditor on account of the claims asserted in the litigation that gave rise to those judgments.

Based on the undisputed facts, the Court finds and concludes that Plaintiff did not receive adequate notice of either the pendency of the bankruptcy case or the time within which to

file a complaint objecting to discharge. Consequently although the deadline to object has technically expired, due process requires that the Plaintiff be given an opportunity to object to the Debtor's discharge or the discharge of the Debtor's debt allegedly owed to Plaintiff.

IT IS THEREFORE ORDERED granting Plaintiff until October 31, 2005 to amend her existing complaint to allege what debts she claims to be owed (other than the California judgments), and to allege grounds why those debts should be excepted from the discharge pursuant to 11 U.S.C. § 523, or why the Debtor should be denied a discharge pursuant to 11 U.S.C. § 727.
