8	The Debtors filed a joint chapter 13 petition on August 23, 2004. In their schedules they
9	listed:
10	Secured debt (all undisputed) \$ 226,167
11	Priority unsecured claims (all undisputed) 24,015
12	Unsecured claims 483,041
13	
14	As for the unsecured claims, only one was listed as disputed, but with a "zero" balance. Therefore, that
15	claim (to the IRS) is not included within the \$483,041 total set forth above. (Docket #9.)
16	On February 1, 2005, the Trustee filed a motion to dismiss, alleging that the Debtors had
17	unsecured, undisputed debt which exceeded the \$290,525 limit of 11 U.S.C. § 109(e).
18	The Debtors argue that this status must exist "on the day of filing," and states several
19	challenges that they might have to various filed claims. The filed claims, noted the trustee, were in the
20	sum of \$505,591.40. (Docket #17.) However, to date, no objections to claims have been filed. See
21	Fed. R. Bankr. P. 3007.
22	Debtors' argument fails because on the date of filing, the Debtors' own schedules reflect
23	undisputed, non-contingent status totaling:
24	Priority unsecured debt \$ 24,015
25	Unsecured debt483,041
